



Program Withdrawal Protection

ISA Program Withdrawal Protection guarantees a full refund of the program cost, less the \$200 deposit, under any circumstance provided that the official ISA Withdrawal Form is completed by the program participant and submitted to ISA by 5pm at least one business day prior to the official start date of the program. Participants can purchase ISA Program Withdrawal Protection anytime prior to the original payment due date of the program. Program Withdrawal Protection is not available to late applicants.

Any decision to withdraw from an ISA program on or after the official start date of the program will result in no refund. Furthermore, all late fees/change fees/optional added-on fees incurred by the applicant are excluded from the Program Withdrawal Protection. Once paid, the Program Withdrawal Protection fee is non-refundable.

If you are interested in the Program Withdrawal Protection, please complete and return this form and respective payment to ISA prior to the original payment due date for your program. This form is null if payment is not included. Both this form and the fee must be received prior to the original payment due date of the program.

Please note that the Program Withdrawal Protection is non transferable if participant changes program or session. If participant changes program or session, a new Program Withdrawal Protection will need to be purchased to cover the participant's new program, if applicable. The Program Withdrawal Protection is not available to students from Direct Bill universities.
